An Act for the Encouragement of Schools.

Paffed ye 9th day of April, 1795.

Be it enacted by the people of the state of New-York, reprefented in fenate and assembly, That out of the annual revenue arifing to this ftate, from its ftock and other funds, excepting fo much thereof as fhall be necessary for the support of government, the sum of twenty thousand pounds shall be annually appropriated for the term of five yearf, for the purpose of encouraging and maintaining fchools in the feveral cities and townf in this ftate, in which the children of the inhabitantf reliding in the state, shall be instructed in the English language or be taught English grammar, arithmetic, mathematicf, and fuch other branches of knowledge as are most useful and necessary to complete a good English education; which fum shall be distributed among the feveral counties in the manner following until a new apportionment of the reprefentation of the legislature of this ftate fhall be made.

The County of Ontario shall receive the fum of three hundred pounds.

The foregoing is an extract from the first general school law passed in this State. The Act was approved by Governor George Clinton. It provides that there should be in each town not less than three, nor more than seven School Commissioners, and in each district two or more Trustees. Each town was to raise a sum of money equal to one-half of the sum allotted by the State for the same purpose—all to be apportioned on the basis of taxable inhabitants. These amounts were for the support of common schools only.
