

THE CONSTITUTIO]

OF THE STATE OF NEW YORK. WE THE PROFILE of the State of New York, grateful to Almighty God for our Freedom, in order to secure its blessings, DO ESTABLISH this

ARTICLE L. Section 1. No member of this State shall be disfranchised, or deprived of any of the rights or privileges secured to any citizens thereof, unless by the law of the land, or the judgment of his peers. Section 2. The trial by jury, in all cases in which it has been heretofore used, shall remain Section 2. The trial by jury, in an which it has been heretofore used, shall remain inviolate forever. But a jury trial may be waived

by the parties in all civil cases, in the manner to be prescribed by law.

Section 3. The free exercise and enjoyment of Section 3. The free exercise and enjoyment of religious profession and worship, without discrimination or preference, shall forever be allowed in this State to all mankind; and no person shall be rendered incompetent to be a witness on account of his opinions on matters of religious belief; but the liberty of conscience hereby secured shall not be so construed as to excuse acts of licentiousness or justify practices inconsistent with the peace or safety of this state.

Section 4. The privilege of the writ of habeas corrups shall not be assembled with the peace of the writ of habeas.

Section 4. The privilege of the writ of haboas corpus shall not be suspended, unless when, in ca-ses of rebellion or invasion, the public safety may require its suspension.
Section 5. Excessive bail shall not be required

nor excessive fines imposed, nor shall cruel and unusual punishments be inflicted, nor shall wit-nosses be threesenably detained.

Section 6. No person shall be held to answer for a capital or otherwise infamous crime, (except in cases of impeachment, and in cases of militia, when in actual service; and the land and militia, when in actual service; and the land and naval forces in time of war, or which this State may keep with the consent of Congress, in time of peace; and in cases of petit larceny, under the regulation of the Legislatures) unless on presentment or indictment of a grand jury, and in any trial in any ceurt whatever, the party accused shall be allowed to appear and defend in person and with counsel, as in civil actions. No person shall be subject to be twice put in jeopardy for the same offence; nor shall he be compeled in any criminal case, to be a witness against himself;—nor be deprived of life, liberty or property without due process of law; nor shall private property be taken for public use without just compensation.

Section 7. When private property shall be taken for any public use, the compensation to be made therefor, when such compensation is not made by the State, shall be ascertained by a jury, or by not less than three commissioners appointed by a court of record, as shall be prescribed by law. by a court of record, as shall be prescribed by law. Private roads may be opened in the manner to be prescribed by law; but in every case the necessity of the road, and the amount of all damage to be sustained by the opening thereof, shall be first determined by a jury of freeholders, and such amount, together with the expenses of the proceeding, shall be paid by the person to be benefited.

Section 8. Every citizen may freely speak, write and publish his sentiments on all subjects, be-

write and publish his sentiments on all subjects, being responsible for the abuse of that right; and no law shall be passed to restrain or abridge the liberty of speech or of the press. In all criminal prosecutions or indictments for libels, the truth may be given in evidence to the jary; and if it shall appear to the jury that the matter charged as libelous is true, and was published with good motives and for justifiable ends, the party shall be acquitted; and the jury shall have the right to dene the law and the fact.

Section 9. The assent of two-thirds of the nembers elected to each branch of the Legislature shall be requisite to every bill appropriating the public moneys or property for local or private pur-

poses.

Section 10. No law shall be passed, abridging the right of the people peaceably to assemble and to petition the government, or any department thereof, nor shall any divorce be granted, otherwise than by the judicial proceedings, nor shall any lottery hereafter be authorized or any sale of lottery tickets allowed within this State.

Section II The people of this State, in their right of sovereignty, are deemed to possess the ortifiant and ultimate property in and to all lands within the jurisdiction of the State; and all lands the title to which shall fail, from a defect of heirs.

And the said commissioners shall specify such alterations and amendments therein as they shall deem proper, and they shall at all times make reports of their proceedings to the Legislature, when called upon to do so; and the Legislature shall pass laws regulating the tenure of office, the filling of vacancies therein, and the compensation of the said commissioners; and shall also provide for the publication of the said code, prior to its being presented to the Legislature for adoption.

Section 18. All grants of land within this State. acting under his authority, after the fourteenth day of October, one thousand seven hundred and seventy-five, shall be null and void; but nothing contained in this Constitution shall affect any grants of land within this State, made by the au-thority of the said King or his predecessors, or shall annul any charters to bodies politic and corshall affect any such grants or other that day; or shall affect any such grants or charters since made by this State, or by persons acting under its authority, or shall impair the obligation of any debts contracted by this State, or individuals, or bodies corporate, or any other rights of property, or any suits, actions, rights of action, or other pro-ceedings in courts of justice.

ARTICLE II. Section 1. Every male citizen of the age of twenty-one years, who shall have been a citizen for ten days, and an inhabitant of this State one year next preceding any election, and for the last four months a resident of the county where four months a resident of the county where he may offer his vote, shall be entitled to vote a at such election in the election district of which he shall at the time be a resident, and not elsewhere, for all officers that now are or hereafter may be elective by the people; but such citizen shall have been for thirty days next preceding the election, a resident of the district from which the officer is to be chosen for whom he offers his vote.—But no man of color, unless he shall have been for three years a citizen of this State, and for one year next preceding any election shall have been seized and possessed of a freehold estate of the value of two hundred and fifty dollars, over the value of two hundred and fifty dollars, over and above all debts and incumbrances charged thereon, and shall have been actually rated and paid a tax thereon, shall be entitled to vote at such election. And no person of color shall be subject to direct taxation unless he shall be seized and possessed of such real estate as aforesaid.

For the purpose of voting, no person shall be desented to have gained or lost a residence by reason of his presence or absence, while employed in the service of the United States; nor while engaged in the navigation of the waters of this State, or of the United States, or of the high seas; nor while a student of any seminary of learning; nor while kept at any alms house, or other asylum, at public expense; nor while con-fined in any public prison.

Section 4. Laws shall be made for ascertain-

ing by proper proofs the persons who shall be en-titled to the right of suffrage hereby established. Section 5. All elections by the citizens shall be by ballot, except for such town officers as may by law be directed to be otherwise chosen.

ARTICLE V. Section 1. The Secretary of State, Comptroller, Treasurer and Attorney General shall be chosen at a general election, and shall hold their offices for two years. Each of the officers this article named (except the Speaker of the Assembly), shall at stated times, during his con-tinuance in office, receive for his services, a compensation, which shall not be increased or diminished during the term for which he shall have been elected; nor shall he receive, to his use, any fees or perquisites of office, or other

Section 2. A State Engineer and Surveyor shall be chosen at a general election, and shall hold his office two years, but no person shall be elected to said office who is not a practical engi-

Section 3. Three Canal Commissioners shall e chosen at the general election which shall be held next after the adoption of this Constitution, one of whom shall hold his office for one year, one for two years, and one for three years. The Commissioners of the Canal Fund shall meet at the Capitol on the first Monday of January, next after such election, and determine by lot which of said Commissioners shall hold his office for one year, which for two, and which for three years; and there shall be elected annually thereafter, one Canal Commissioner, who shall hold his office for three years.

Section 4. Three Inspectors of State Prisons, shall be elected at the general election which shall be held next after the adoption of this Con-stitution, one of whom shall hold his office for one year, one for two years, and one for three vears. The Governor, Secretary of State, and Comptroller, shail meet at the Capitul on the first Monday of January next succeeding such election, and determine by lot which of said Inspectors shall hold his office for one year, which two, and which for three years; and there shall be elected annually thereafter one Inspect three years; said inspectors shall have the charge and superintendance of the State Prisons, and shall appoint all the officers therein. All vacancies in the office of such Inspector shall be filled by the Governor, till the next election. Section 5. The Lieutenant Governor, Speaker of the Assembly, Secretary of State, Comptroller, Treasurer, Attorney-General and State En-

Section 6. The powers and duries of the respective boards, and of the several officers in this Article mentioned, shall be such as now are or hereafter may be prescribed by law.

Section 7. The Treasurer may be suspended from office by the Governor, during the recess of the Legislature, and until thirty days after the commencement of the next session of the Legislature, whenever it shall appear to him

L-gislature, whenever it shall appear to him that such Treasurer has, in any particular, viothat such Treasurer has, in any particular, violated his duty. The Governor shall appoint a competent person to discharge the duties of the office, during such su-pension of the Treasurer. Section 8. All offices for the weighing, gauging, measuring, culling or inspecting any merchandize, produce, manufacture or commodity, whatever, are hereby abolished, and no such office shall hereafter be created by law; but nothing in this section contained, shall abrogate any office creared for the purpose of protecting the public health or the interests of the State in its property, revenue, tolls, or purchases, or of supplying the people with correct standards of plying the people with correct standards of weights and measures, or shall prevent the creation of any office for such purposes hereafter. ARTICLE VI

Section 1. The assembly shall have the power of impeachment, by the vote of the majority of all the members elected. Section 3. There shall be a supreme court hav ing general jurisdiction in law and equity.

Section 4. The State shall be divided into eight

judicial districts, of which the city of New-York shall be one; the others to be bounded by county lines and to be compact and equal in population as nearly as may be. There shall be four Justices of the Supreme Court in each district, and as many more in the district composed of the city of New York, as may from time to time be authorized by law, but not to exceed in the whole such number in proportion to its population, as shall be in conformity with the number of such judges in the residue of the State in proportion to its population. They shall be classified so that one of the justices of each district shall go out of office at the end of every two years. After the expiration of their terms under such classifi-cation, the term of their office shall be eight

Section 5. The Legislature shall have the same powers to alter and regulate the jurisdiction and proceedings in law and equity, as they have hereto-

ore possessed.

Section 6. Provision may be made by law for designating from time to time, one or more of the said justices, who is not a judge of the court of appeals, to preside at the general terms of the said court to be held in the several districts. Section 10. The testimony in equity cases shall be taken in like manner as in cases at law.

Section 11. Justices of the supreme court and adges of the court of appeals, may be removed by concurrent resolution of both Houses of the Legislature, if two-thirds of all the members elect-ed to the Assembly and a majority of all the members elected to the Senate, concur therein. All judicial officers, except those mentioned in this section, and except justices of the peace, and judges and justices of inferior courts not of record may be removed by the Senate on the recommen-dation of the Governor; but no removal shall be made by virtue of this section, unless the cause thereof be entered on the journals, nor unless the party complained of, shall have been served with of the complaint against him, and shall have had an opportunity of being heard in his de-fence. On the question of removal, the ayes and noes shall be entered on the journals.

Section 12. The judges of the court of appeals hall be elected by the electors of the State, and the justices of the supreme court by the electors of the several judicial districts, at such times as

may be prescribed by law.

Section 13. In case the office of any judge of the court of appeals, or justice of the supreme court, shall become vacant before the expiration of the regular term for which he was elected, the of the regular term for which he was elected, the vacancy may be filled by appointment by the Governor, until it shall be supplied at the next general election of judges, when it shall be filled by election for the residue of the unexpired term.

Section 14. There shall be elected in each he counties of this State, except the city and county of New York, one county judge, who shall hold his office for four years. He shall hold the county court, and perform the duties of the office of surrogate. The county court shall have such jurisdiction in cases arising in justices courts, and in special cases, as the Legislature may pre-scribe; but shall have no original civil jurisdiction,

except in such special cases.

The county judge, with two justices of the peace to be designated according to law, may hold courts of sessions, with such criminal jurisdiction as the Legislature shall prescribe, and perform such other duties as may be required by law.

The county judge shall receive an annual salary, to be fixed by the board of supervisors, which shall be neither increased nor diminished during nis continuance in office. The justices of the peace, for services in courts of sessions, shall be paid a per diem allowance out of the county

reasury.

A clerk for the Court of Appeals, to be ex-officio clerk of the Supreme Court, and to keep his office at the seat of government, shall be cho-sen by the electors of the State; he shall hold his office for three years, and his compensation shall be fixed by law and paid out of the public Trea-

Section 22. The Legislature shall provide for the speedy publication of all statue laws, and of such judicial decisions as it may deem expedient.

And all laws and judicial decisions shall be free

for publication by any person.

Section 23. Tribunals of conciliation may be established, with such powers and duties as may be prescribed by law, but such tribunals shall have no power to render judgment to be obligatory on the parties, except they voluntarily submit their matters in difference and agree to abide the judgment, or assent thereto, in the presence of such tribunal, in such cases as shall be

ed by law.
Section 24. The Legislature at its first session after the adoption of this Constitution, shall provide for the appointment of three commissioners whose duty it shall be to revise, reform, simplify and abridge the rules and practice, pleadings forms and proceedings of the courts of record of this State, and to report thereon to the Legisla-ture, subject to their adoption and modification

from time to time.

Section 25. The Legislature at its first session after the adoption of this Constitution, shall provide for the organization of the Court of Appeals, and for transferring to it the business pending in the Court for the Correction of Errors, and for the allowance of writs of error and appeals to the Court of Appeals, from the judgments and decrees of the present Court of Chancery and Supreme Court, and of the courts that may be organized under this Constitution.

ARTICLE VII

Section 1. After paying the expenses of collection, superintendence and ordinary repairs, there shall be appropriated and set apart in each fiscal year, out of the revenues of the State canals, commencing on the first day of June, one thousand eight hundred and forty-six, the sum of one million and three hundred thousand dollars until the first day of June, one thousand eight hundred and fifty-five, and from that time the sum of one million and seven hundred thousand dol lars in each fiscal year, as a sinking fund, to pay the interest and redeem the principal of that part of the State debt called the canal debt, as it existed at the time first aforesaid, and including three hundred thousand dollars then to be borrowed, until the same shall be wholly paid; and the Section 2. After complying with the provisions of the first section of this article, there shall be ap-

propriated and set apart out of the surplus revenues of the State canals, in each fiscal year, com-mencing on the first day of June, one thousand eight hundred and forty-six, the sum of three hundred and fifty thousand dollars, until the time when a sufficient sum shall have been appropriated and set apart, under the said first section, to pay the interest and extinguish the entire principal of the canal debt; and after that period, then the sum of one million five hundred thousand dollars in each fiscal year, as a sinking fund, to pay the interest and redeem the principal of that part of the State debt called the General Fund debt, including the debt for loans of the State credit to rail road companies which have failed to pay the interest thereon, and also the contingent debt on State stocks loaned to incorporated companies which have hitherto paid the interest thereon, whenever and as far as any part thereof may become charge on the Treasury or General Fund, unti the same shall be wholly paid; and the principal and income of the said last mentioned sinking fund shall be sacredly applied to the purpose aforesaid and if the payment of any part of the monies to the said sinking fund shall at any time be deferred by reason of the priority recognized in the first section of this article, the sum so deferred, with quarterly interest thereon, at the then current rate, shall be paid to the last mentioned sinking fund, as soon as it can be done consistently with the just rights of the creditors holding said canal debt.

Section 3. After paying the said expenses of su perintendence and repairs of the canals, and the sums appropriated by the first and second sections of this article, there shall be paid out of the surplus revenues of the canals, to the Treasury of the State, on or before the thirtieth day of September, in each year, for the use and be the General Fund, such sum, not exceeding two hundred thousand dollars, as may be required to defray the necessary expenses of the State; and the remainder of the revenues of the said canals shall, in each fiscal year, be applied, in such manner as the Legislature shall direct, to the completion of the Erie Canal enlargement, and the Gen-esee Valley and Black River canals, until the said

canals shall be completed.

If at any time after the period of eight years from the adoption of this Constitution, the revenues of the State, unappropriated by this article, shall not be sufficient to defray the necessary expenses of the government, without continuing or laying a direct tax, the Legislature may, at its dislaying a direct tax, the Legislature may, at its dis-cretion, supply the deficiency, in whole or in part, from the surplus revenues of the canals, after com-plying with the provisions of the first two sections of this article, for paying the interest and exting-guishing the principal of the Canal and General Fund debt; but the sum thus appropriated from the surplus revenues of the canals shall not exceed annually three hundred and fifty thousand do including the sum of two hundred thousand dol-lars, provided for by this section for the expenses of the government, until the General Fund debt shall be extinguished, or until the Erie Canal Enargement and Genesee Valley and Black River Canals shall be completed, and after that debt shall be paid, or the said canals shall be completed, then the sum of six hundred and seventy-two thousand five hundred dollars, or so much thereo as shall be necessary, may be annually appropriated

to defray the expenses of the government.

Section 4. The claims of the State against any incorporated company to pay the interest and re-deem the principal of the stock of the State loandeem the principal of the stock of the State loan-ed or advanced to such company, shall be fairly enforced, and not released or compromised; and the moneys arising from such claims shall be set apart and applied as part of the sinking fund pro-vided in the second section of this article. But ided in the second section of this article. the time limited for the fulfillment of any condi tion of any release or compromise heretofore made or provided for, may be extended by law.

Section 5. If the sinking funds, or either of them provided in this article, shall prove insufficient to nable the State, on the credit of such fund, to pro cure the means to satisfy the claims of the credi care the means to satisfy the claims of the credi-tors of the State as they become payable, the Le-gislature shall, by equitable taxes, so increase the revenues of the said funds as to make them, re-spectively, sufficient perfectly to preserve the public faith. Every contribution or advance to the canals, or their debt, from any source, other than their direct revenues, shall, with quarterly inter est, at the rates then current, be repaid into the Treasury, for the use of the State, out of the ca-

any manner, be given or loaned to, or in aid of any individual association or corporation.

Section 10. The State may, to meet casual deficits or failures in revenues, or for expenses not provided for, contract debts, but such debts, direct and contingent, singly or in the aggregate, shall not at any time, exceed one million of dollars; and the moneys arising from the loans creating such debts, shall be applied to the purpose for which they were obtained, or to repay the debt so contracted, and to no other purpose whatever.

Section 11. ARTICLE VIII. Section 1. Corporations may be formed under general laws; but shall not be created by special act, except for municipal purposes, and in cases wherein the judgment of the Legislature, the objects of the corporation cannot be attained under general laws. All general laws and special acts passed pursuant to this section, may be altered from time to time or repealed.

Section 2. Dues from corporations shall be secured by such individual liability of the corporators and other means as may be prescribed by

Section 3. The term corporations as used in this article, shall be construed to include all associations and joint stock companies having any possessed by individuals or partnerships. And all corporations shall have the right to sue and shall be subject to be sued in all courts in like

cases as natural persons.
Section 4. The Legislature, shall have no pow er to pass any act granting any special chart for banking purposes; but corporations or asso-ciations may be formed for such purposes under general laws.
Section 5. The Legislature shall have no pow-

er to pass any law sanctioning in any manner, directly or indirectly, the suspension of specie payments, by any person, association or corpo ration issuing bank notes of any description. Section 6. The Legislature shall provide by law for the registry of all bills or notes, issued or put in circulation as money, and shall require ple security for the redemption of the same

Section 7.
