

## Benevolent Institutions of Rochester.

### FEMALE CHARITABLE SOCIETY.

[The following brief sketch of the rise and progress of this truly benevolent institution, was prepared by Mrs. JAMES K. LIVINGSTON, but was not designed for publication. On application, however, as this work was about to be put to press, it was kindly furnished for insertion.]

ROCHESTER, November 4, 1844.

The compiler of the following facts is indebted chiefly to the *memories* of the early founders of the Charitable Society—still these are mere fragments. The most important items they do not furnish; and by some strange fatality, nearly all documentary evidence, prior to the year 1827, appears to be lost. Previous to the year 1822, it seems a “Charity School” had been taught alternately by Ladies, in a room on State-street, owned and gratuitously granted for the purpose, by the late Mr. JOSIAH BISSELL, near the premises now occupied by the City Bank. The educational wants of the poor, together with other destitutions consequent upon sickness in a new country, prompted the foundation of this Society, on the 26th day of February, 1822, for the purpose of more efficient action. Thus, we find even at this early day, that our citizens considered the poor, and according to their ability, afforded them advantages equal to their own, for schools of any kind were at this period, “few and far between.”

The Society was first organized at the house of Mr. EVERARD PECK, and Mrs. P. was chosen Treasurer. The primary object of this Society, as stated in the Constitution, were, the relief of indigent sick persons, and the establishment of a Charity School. A President, Vice President, Treasurer, twelve Directresses, and about fifteen Visitors, were chosen. Business, at this time, was transacted by the Society, and it was not until the year 1827, that powers were delegated to the officers of the Society, to transact, as a Board of Managers, its ordinary affairs, except at the annual meeting. The first garments collected for distribution, were donations from the ladies, of some articles needed. Beds and bedding, and other conveniences for the sick, were at that time, and have been ever since, lent to the individuals, to be returned by the Visitor, upon their recovery. Infants' clothing has been given

from time to time; and for many years the children of the school were clothed by the Society. A school lot was presented by the late Col. FITZHUGH, situated, at that time, upon the outskirts of the *Village*, near the forest, but which, it was known, would soon be valuable. It is now an eligible lot on North Washington-street, with a plain building upon it. Since the establishment, however, of our Common School System in this city, this school has been discontinued, except for the purpose of teaching the children of the poor to sew. This plan is at present an experiment, and is far from being perfected. The number of districts for the visitation of the sick has increased from fifteen to forty-three. The duties of the Treasurer are already quite onerous.

One happy feature of the Society, has been its freedom from all bigotry of sect or party—all classes of our citizens are cordially invited to lend a helping hand; while, also, all classes who need its aid, share with equal willingness in its benefits. It has long constituted a bond of union amongst our citizens, of the most agreeable character. Its assistance has been extended, in several instances, to some of the most valuable citizens as well as ornaments, of any community, but whom misfortune has reached, and to whom the voice of kindness and mercy were as sweet as to the lowest child of sorrow.

A Sermon has been preached annually in aid of its funds. Its *first* sermon was preached by the Rev. Mr. CUMMING, of St. Luke's Church; and, as a village paper remarked, a handsome sum was taken up in aid of its funds. In 1823, the Rev. Mr. PENNEY preached the sermon. It appears that the Society was then prosecuting its labors effectually; for an article published after the annual meeting of the Society, says, "It would be an offence against God and Humanity, to withhold from these almoners of Heaven, who are carrying education, nourishment, and consolation, into the retreat of sickness and misery, the means of continuing their divine ministrations." In 1825, the Rev. Mr. MILLER preached the sermon, and the collection had increased to \$46. Its income and its expenditure have varied much in different years—but its calls for aid have always met with a cheerful response.

The prosperity, nay, the very existence of the Society, will soon be committed to a *new generation*; for a few more cycles will complete the thirty years of its continuance, during which time the heads that planned, and the hands that executed, this charity, and who yet remain amongst us, will, many of them, have rested from their labors, "urging upon their successors, to do with their might what their hands find to do."

## ORPHAN ASYLUMS.

## ROCHESTER ORPHAN ASYLUM.

This Institution was established in 1836, and incorporated in 1838. The Asylum is situated between Greig and Exchange streets, in the south part of the city, on an elegant site, the munificent donation of Mr. GREIG, of Canandaigua. Forty-four children now occupy the Asylum: they are under the maternal care of Mrs. FLORILLA TOBEY, (to whom we are indebted for these items,) who has filled this station, to the entire satisfaction of all interested, for eight years. The School is taught by Miss ARAMINTA G. HUNT, and the Sabbath School by Mr. EVERARD PECK. Average number of children admitted during the year, 50. Average number of deaths annually, 2—which should be deemed remarkable, as more than one half of the children admitted, are diseased,—thus presenting conclusive evidence of the kind treatment they receive. The meetings of the Society are held on the last Tuesday in each month; annual meeting, 2d Tuesday in October.

The charter requires that the estate and financial concerns of the Institution, shall be managed by seven Trustees, to be elected at the annual meeting of the Association. The general supervision of the children, and interests of the asylum, are committed to the Ladies, who constitute a Board of Managers. ## ROMAN CATHOLIC ORPHAN ASYLUM.

This Institution for the support and education of destitute orphan children, is situated on Frank-street, in rear of St. Patrick's Church, the ground on which it stands being the property of that congregation. It is a large and handsome brick building, and was opened for the reception of inmates, in July, 1842, since which time forty-nine destitute orphans of both sexes have been admitted. Of this number twenty-seven (all females) are at present in the house, the few remaining male children being supported *out* of the Institution. The means of support are derived from the subscriptions of the members of the Catholic Orphan Asylum Society, lately incorporated by the Legislature; from the donations of charitable individuals; and from the proceeds of Annual Fairs, which have hitherto been liberally patronized by the citizens of Rochester generally.

This establishment is under the exclusive management of SISTERS OF CHARITY, who also teach a select School, "THE ST. PATRICK'S FEMALE SEMINARY," in one of the school rooms of the Church, which is attended on an average by about fifty pupils.

## ROCHESTER FEMALE MORAL REFORM SOCIETY,

Auxiliary to the "NEW-YORK CITY MORAL REFORM SOCIETY," was organized April 13, 1836. The Society meets at the residence of Mrs. SELAH MATHEWS, 77 South Fitzhugh-street, for the transaction of business, on the 3d Wednesday of each month—it is composed of about 500 members. Annual meetings, for the election of officers, &c., takes place on the 3d Wednesday in June of each year. The funds of the Society at present are limited, yet it affords aid to such of the unfortunate, as are disposed to return to habits of rectitude and virtue; and has also contributed to the treasury of the parent society. An annual subscription of 25 cts. per year, of each member, is expended in the purchase of appropriate tracts, &c., which are freely circulated among that class, whose condition, spiritual and temporal, they seek to ameliorate. Brief addresses on the subject of Moral Reform, are delivered before the Society at its meetings, by gentlemen appointed for that purpose. The following Ladies are the officers for 1845-6:

## THE ROCHESTER SUNDAY SCHOOL UNION.

Embracing all denominations of Evangelical Christians, was formed in April, 1822. The number of Schools connected with the Union, at that time, was four; embracing about 150 Scholars. Monthly Meetings of the Union have been regularly held since its first organization; at which a report of the condition of each School is presented. It embraces, at this time, sixteen Schools, which are connected with the following Churches, viz.: First Presbyterian Church, Brick (Presbyterian) Church, Third Presbyterian Church, Washington-street (Presbyterian) Church, State-street Congregational Church, First Baptist Church, Second Baptist Church, St. John's (Methodist Episcopal) Church, and St. Luke's (Episcopal) Church, together with seven other Schools in charge of the Association, but not connected with any church organization. Numbering in all, 3,322 Scholars. About 5,500 volumes of religious books are contained in their Libraries; and about 1000 religious papers are taken regularly by the Scholars. Sixteen thousand different Scholars have been taught in these Schools since their organ-

ization ; about 1500 of whom have been hopefully converted to God, and become Members of the Church of Christ. These have been scattered far and wide over our country, carrying with them the life-giving influence of Truth ; several have entered the Ministry, and are now proclaiming the glad news of Salvation to the Heathen, and others are in a course of preparation for the Ministry. ## Common Schools.

### BOARD OF EDUCATION.

The Free School System was established in this city, in May, 1841, and is under the control of a Board of Education, consisting of two Commissioners from each Ward, who are elected on the 3d Tuesday in June, of each year. The Superintendent is appointed by the Board. Through this system it is calculated that every child in the city is entitled to an education, gratuitously, directly—the system receiving its support from a general tax. There are, at present, fifteen School Districts, in most of which have been erected commodious and comfortable School Houses—the majority of which are of brick, and are not at all inferior to many of the Academies of this State. In addition to the above, there is a school for colored children, embracing the entire city. About 4,500 children were in attendance at these Schools, during the year 1844—average attendance, over 3000. Cost of School Houses, over \$40,000. The amount annually raised by tax for their support, is from \$10,000 to \$11,000. The Board for the year 1845-6, consists of the following gentlemen :
